## Modalités de départ

**RDV** sur le parking devant le Lycée Ambroise Croizat à proximité de Bois Espace dimanche 22 septembre à **7h45** pour un départ en bus à 08h00 (temps nécessaire pour le contrôle des documents).

**Vous devrez être obligatoirement muni de votre carte d'identité ou de votre passeport pour monter dans le car.**

En cas de retard, téléphonez à Mme Dalgé ou Mme Guyomarch et allez à l'aéroport St Exupéry de Lyon Terminal 2 par vos propres moyens.

Arrivée à Malta International Airport à 14h50.

Votre billet d'avion vous sera donné à l'aéroport par vos accompagnateurs juste avant l'enregistrement des bagages. Lors de l'enregistrement, on vous délivrera **une carte d'embarquement** que vous devrez conserver **précieusement**. **Ne jetez pas votre carte d'embarquement à l'arrivée à Malte. Elle sert de justificatif financier.**

## Les bagages

Le contenu, le poids et la taille des bagages que vous emportez sont réglementés par les compagnies aériennes. Respectez ces contraintes, **tout manquement pouvant entraîner des coûts supplémentaires à la charge des familles.**

**Sur Air Malta, vous avez le droit à :**

- un bagage en soute de 23 kg maximum par participant.
- un seul bagage cabine de taille maximale de 56x45x25 cm (poignées et roulettes comprises) et 10 kg maximum. Les dimensions de vos bagages sont vérifiées avant l'embarquement. Tout bagage dont la taille dépasse 56 x 45 x 25 cm (poignées et roulettes comprises) ne peut être transporté en cabine et devra être mis en soute et facturé comme tel.  
**Mettez impérativement dans votre bagage cabine tous les documents administratifs, les objets fragiles et de valeur ainsi qu'une tenue professionnelle.**
- Prévoir un sac **un petit sac à dos** (les excursions, travail...)
- Prenez **un parapluie**, pliable de préférence et **une veste ou blouson imperméable**.
- **PRENEZ VOTRE TENUE PROFESSIONNELLE** (vêtements et chaussures)
- **Pensez à amener des stylos, surligneurs et crayon à papier (travail...)**
- **Prenez un adaptateur prise électrique anglaise.**
- **Si vous suivez un traitement médical, fournissez le traitement pour 1 mois et une photocopie de l'ordonnance.**
- Prévoir 1 petit panier repas à base d'aliments secs (sandwichs, biscuits, fruits) pour le **repas du midi** ou une somme d'argent (10 à 15 euros)

  - les instruments tranchants comme les couteaux ou les ciseaux dont la lame dépasse 6cm ;

  - les substances explosives ou incendiaires et imitations telles que les feux d'artifice ou les fumigènes.

## Programme à l'arrivée

1. **Donnez impérativement votre carte d'embarquement à vos accompagnateurs pendant l'attente de vos bagages.**

2. Achetez votre carte de bus avec vos accompagnateurs à l'aéroport.

Prévoir 21 euros.



3. Un chauffeur de taxi acheminera le groupe ainsi que les professeurs jusqu'à l'hébergement. Il vous donnera les clés de l'appartement. Vous ferez alors individuellement un état des lieux de l'appartement et de votre chambre.
4. Faites des courses pour 2 jours ! Certains magasins sont ouverts le dimanche jusqu'à 20h30 ou minuit. Faites une recherche sur google map ou autre application.

## Programme du lundi 23 septembre

1. **RDV à 7h45** en bas de votre appartement en tenue professionnelle. Vos accompagnateurs viendront vous chercher pour vous amener à l'agence Easyjobbridge.
2. Accueil à 9h à Easyjobbridge :
  - Mots de bienvenue
  - signature des contrats d'hébergement. Vous devrez fournir une **caution de 100 euros en espèces uniquement.** Cette caution vous sera redonnée à la fin de votre séjour s'il n'y a pas de dégradations.
3. Prise de contact avec votre entreprise d'accueil. Vous serez acheminé en taxi avec un membre d'Easyjobbridge et un de vos professeurs, et serez présenté à votre tuteur. On vous donnera alors votre emploi du temps. **Repérez bien l'arrêt de bus et la ligne de bus que vous devrez prendre.**

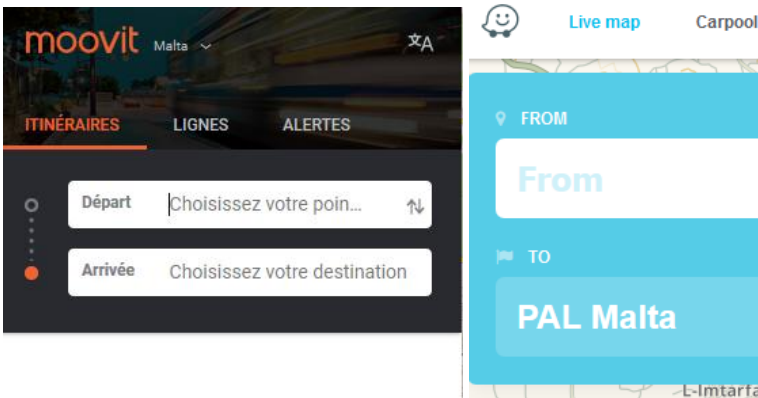

## HOW TO COME TO OUR OFFICE

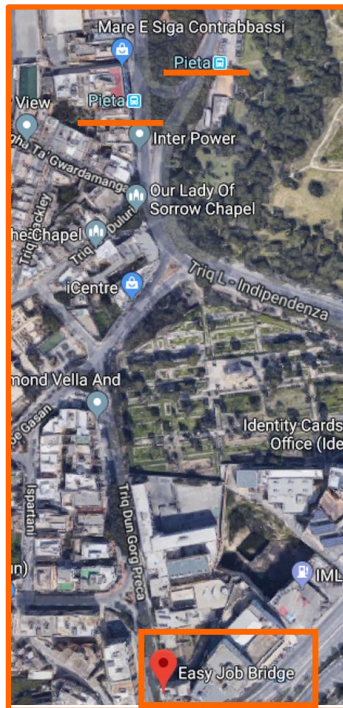
Click [here](#) to find us on Google Maps.

Please find maps below of how to reach our offices from any of our apartments. To come to Hamrun, please catch any bus going to Valletta (usually 2-digit bus numbers, destination: Valletta) and stop at one of the bus stops indicated below accordingly.



Coming from the south of Malta, bus stop where you should get off the bus is [Blata I-Bajda 5](#). From **Blata I-Bajda 5** you need to climb the stairs on your right hand side then cross the road in front using the pedestrian lights to get to [Blata I-Bajda 1](#) bus stop where you need to keep walking round the corner on the right hand side and cross the road again using the zebra crossing. Our office is located

in from of the zebra crossing. From the centre of Malta bus stop to be used is **Blata l-Bajda 1**.



From the Northern part of the island, bus stop to be used is **Pietà**. When you get off the bus at Pietà bus stop, you should turn around and cross the road using the pedestrian lights to the other side of the road where the buildings are. Once you reach the buildings, walk to your left (uphill, away from the sea) up Triq Marina, then take a right on Triq Joe Gasan, then a left up Triq Dun Gorg Preca. Keep walking up the street on the left-hand side, past St Joseph School, until the last building on the street which is where we are located and look for our logo outside.

Please use the pedestrian lights or zebra crossings provided to cross all the roads/streets that you need to cross.

Our full address is: **6, Spencer Flats, Flat 3, Triq Dun Gorg Preca, Hamrun**. We are on the **third floor** – press number 3 inside the lift or climb up to the third floor using the stairs. There will be our logo again next to our office door in the corridor on the inside of the building.

## WHAT CONSTITUTES AN EMERGENCY

In case of medical or fire emergencies, call **112**.

Regarding your **airport transfer** kindly contact your driver at **+356 9930 3135** if s/he fails to show up for arrival / departure transfer 20 minutes after scheduled time. Call only the emergency phone if you cannot reach him/her.

You should only call our **emergency phone +356 7777 6543** for the following reasons:

- Power cut which is specific to an apartment and not a general power cut.
- No tap water for more than 12 hours.
- Acts of vandalism in an apartment for which you are not responsible.
- Any cases of medical emergency or fire after calling 112.
- Any serious health issues/injuries for which you need assistance by an EJB representative.
- If you've locked yourself out of an apartment or on the balcony out of negligence/by accident, please note that we shall retain €30 from your apartment deposit if a representative has to bring you a key on site.
- Strong suspicion that your apartment has been broken into / burglarised.
- Any cases of flooding in the apartment.
- Key to apartment not working upon arrival.

## WHAT DOES **NOT** CONSTITUTE AN EMERGENCY

Each call to that is **NOT** an emergency, will carry a **10€ charge** which will be taken from your deposit.

- Wi-Fi issues in accommodation.
- Gas shortage.
- Any burnt light bulb.
- Lost keys (charge of €10).
- Matters related to your internship.
- Directions to our office. Kindly use Google Maps or our office number.
- Justified absenteeism – if you are sick and unable to go to work, please inform your host company.
- Power cut when it is evident that the whole neighbourhood is experiencing a general power cut.
- Stove/washing machine/air conditioner/refrigerator/water heater not working. Please report such issues on the next working day following discovery of the fault.
- Comments about the cleanliness or lack of it in an apartment. This should be reported to your EJB mentor via email.
- Any matter that can wait till our office working hours.



## USEFUL INFORMATION ABOUT MALTA

### Tap water

Do not drink the tap water. Tap water is only safe to use when cooking and cleaning. Kindly add water in your budget.

### Driving

We drive on the left as in the UK.

### Electrical plugs

The electrical supply is 230 volts, 50 hertz. We use the three-pin rectangular plug system like in the UK type of electric plugs NOT European! So remember to get one adapter with you or you can buy it here in electrical shops.

### Hospitals and health centres

In case you are sick or you wish to visit a doctor, kindly take with you your social security card. Your first stop should be the Health Centre. Depending on your location, check the closest health centre near you. For example, for apartments in Msida, this should be the [Gzira Health Centre](#) and for those in Qormi, this would be the [Qormi Health centre](#). They are open during normal shopping hours. On Sundays, they usually open by roster from 09h00 to 12h00 in Malta and from 07h30 to 11h00 in Gozo.

### Currency & banking

Malta's currency is the Euro (€). Major credit cards (Visa, MasterCard, American Express, etc) are accepted in most shops but we suggest that you exchange your money to Euro cash for greater flexibility.

Banking hours are usually from 08h30 to 14h00, Monday to Friday and 08h30 to 12h00 on Saturday. In summer, bank experience reduced hours from 8h00 to 13h00.

Foreign exchange facilities are available around the island. Foreign Exchange ATM's are also available in the main cities (Valletta, Sliema and St Julian's).

### Shopping

Generally speaking, shops are usually open from 09h00 to 13h00 and from 16h00 to 19h00 hours. In the commercial areas frequented by tourists most

shops remain open until approximately 22h00. Shops are not open on Sundays and public holidays except selected supermarkets and shopping malls. Please check their opening hours.

## Traffic

Because there is a lot of traffic during rush hours (7h00 to 9h00 and 17h00 to 18h00), we recommend you to plan your trip by bus in advance.

## Bus Cards a.k.a Tal-Linja Cards



We recommend you to **apply for a local bus card** online before your arrival to save some money. During the application, please give **our school address** so the card would be delivered to us and you could collect it from here (it takes few weeks). Click [here](#) to access the

online registration. The address of the school for cards delivery is the following: **Easy School of languages, 21, St Ursula Street, Valletta, VLT 1230, Malta**. The card will arrive by registered post so we can sign for it at reception. Kindly note that it takes approximately 2 weeks for the card to be delivered.
